As we return to live performances at The Community Concert Hall at Fort Lewis College, we will do everything possible to ensure the safety and health of our audiences, staff, students, volunteers and our performers. We are operating at normal capacity, with 100 percent of theater seats offered for sale at each event.

We have moved to contactless ticketing. Tickets can be purchased <u>online</u> or by phone. Your e-tickets can be printed and brought in from home or shown from your mobile device at the door. Proof of full vaccination is required for everyone over the age of 12. This includes patrons, artists, staff, volunteers, and crew members. We'll ask to see your official vaccination card along with a photo ID. Photocopies and photos displayed on your phone are accepted or you may show your Vaccine Record from the **myColorado** app available here.

"Full vaccination" means you've received the complete dosage of the Moderna, Pfizer, or J&J vaccine or other vaccines approved by the World Health Organization—at least 14 days prior to your Community Concert Hall visit. Admittance to an event will be denied if guests cannot provide proper credentials.

Health Self-Checks

We ask that patrons review their health status before attending an event at the Community Concert Hall. If you are exhibiting symptoms, have been exposed to someone with COVID-19 or tested positive in the past two weeks, kindly postpone your visit. Refunds will be offered for health-related cancelations.

For those not vaccinated, we will also accept negative test results from a PCR COVID-19 test (not a rapid test) taken within 72 hours of showtime. If you need assistance finding a test or vaccination location, here is a great resource: https://sjbpublichealth.org/testing/

*Privacy Note: The Community Concert Hall at Fort Lewis College will never share your vaccination information.



Masks required for children: Children ages 2-through-11 are exempt from providing proof of vaccination or a negative COVID-19 test, but a properly fitted face mask must be worn at all times, except when eating or drinking. Children under the age of 2 are exempt from wearing a face mask.

Performers: Entertainers will not be masked during performances.

Audiences: The Community Concert Hall requires face masks to be worn by all patrons, staff, volunteers, and backstage crew members. This face mask policy will protect the health of others in our community and, we hope, provide an extra level of comfort for everyone who attend performances.
